| Event Format                | : | The Asia/Oceania Final Qualifying zone will adopt a format of play designed to give all teams the best possible chance to qualify but this will be confirmed at a later date, when precise entry figures are known.   |
| Hospitality                 | : | Hospitality should commence <b>the evening before</b> the practice day<br>for each team and <b>end with breakfast</b> the day after play has finished<br>(maximum 3 players and 1 non-playing captain per team).  |
